98th ANNUAL ALL INDIA ART EXHIBITION OF PAINTINGS, SCULPTURES, DRAWINGS & GRAPHICS (Exhibition from: 9th to 24th December 2025).

THE RULES AND REGULATIONS OF THE EXHIBITION:-

No original work should be sent to the Society unless asked for.

All artists should send the photographs of their original works in the size of 5"×7". The selection will be made by the Jury on the basis of the photographs only. The artists whose works are selected will be informed to send their original works i.e. Paintings, Sculptures, Drawings and Graphics.

Date of receiving photos of work and schedules is from 18th to 30th August, 2025 between 11 am and 5 pm on all working days.

MAXIMUM NUMBER OF ENTRIES: 2 (Two) in each Category

AWARDS

- 1. Four cash awards of ₹ 50,000 each (one award in each category i.e. Paintings, Sculptures, Drawings and Graphics for the Best Exhibits).
- 2. Twenty cash awards of ₹ 20,000 each (Five awards in each category i.e. Paintings, Sculptures, Drawings and Graphics).

The selection and judging committee is at liberty to withhold any number of awards if they do not find entries up to the mark.

Outstation awardees would be given maximum three tire A.C railway fare to and fro to attend the inaugural function to receive the award in person. **The awardees have to make their own arrangement for boarding and lodging.**

MAXIMUM SIZE of selected work

Paintings : 4'×4' (120×120cms) with frame
Drawings & Graphics : 2'×3' (60×90cms) with frame
For Sculptures : 3'×3'×2' (90×90×60cms)

(Sculpture of fragile materials i.e. glass, clay, paper, plaster of paris, terracotta or any other material consisting of many small loose elements will not be accepted)

The selected artist of the above exhibition may send their original works i.e. Water Color, Graphics and Drawings if they so desire without frame by postal, parcel & the society will frame the selected entries free of charge.

Frames with glass are available in the following sizes.

• 16"×20" • 20"×24" • 24"×30" • 30"×40"

ELIGIBILITY:

- a) The exhibition is open to all artists in India, who have, completed the age of 25 years as on 1.12.2025.
- b) The exhibition is also open to artists of Indian origin settled abroad.
- c) All foreign artists staying in India for more than two years are also eligible to apply.

ENTRY FEE:

An entry fee of ₹ 1000 per schedule per category. No exhibit will be placed before the Selection and Judging Committee unless the entry fee is paid. The entry Fee has to pay by Money Order/ Bank Draft or in Cash. Bank Draft should be in favour of "All India Fine Arts & Crafts Society" payable at New Delhi. Cheques and Postal Orders will not be accepted.

SCHEDULE & SUBMISSION OF EXHIBITS

The enclosed schedule must be filled properly and should be sent along with photographs of their original works and entry fee as per dates mentioned in the schedule. Addressed to The Chairman, AIFACS, 1, Rafi Marg, New Delhi-110001.

Note:

ACCEPTANCE:

No entry will be accepted for the exhibition which has already been displayed in any of the society's exhibitions. An exhibit which has already received an award in any All India Art Exhibition, (within India) should not be submitted for competition.

Exhibit which has been executed before 1.12.2023 will not be accepted.

SELECTION & JUDGING:

The judging process for the 98th Annual All India Art Exhibition will be conducted in two phases: Phase 1: The jury will evaluate photographs of the submitted artworks and shortlist the entries. Phase 2: The shortlisted original artworks will then be physically examined by the jury. Final selections and award decisions will be made based on this inperson assessment. The decision of the judging committee would be final and no correspondence whatsoever will be entertained by the Society.

Names of the Judges would be published in the catalogue.

INSURANCE:

The Society will endeavour to take every possible care for the safety of the exhibits during custody/display/transit and return of the same but would not be responsible for any loss or damage during display, storage or transit and no claim to this effect will be entertained.

The exhibitors are advised in their interest to insure their works at their cost before submitting for the value they deem fit to avoid disappointment in the event of loss or damage if they so desire.

SALE:

- a) All sales will be negotiated by the All India Fine Arts & Crafts Society and the society will retain 20% on all sales for the "AIFACS ARTISTS WELFARE FUND". The balance of 80% will be paid to the artist by cheque.
- b) Authentication Certificate has to be signed by the artist for the buyer. For better sale, the artist are advised to price their exhibits reasonably.

CATALOGUE:

The Society reserves the right to reproduce the works in the catalogue or any other publication or to supply photographs of the same to the Press publicity purposes. Each participant will be given complimentary copy of the catalogue.

CHANGE OF ADDRESS:

Artists should notify the change of their address if any, immediately to the society.

RETURN OF WORKS:

Local artists are requested to take back their works within 10 days after the closing of the exhibition. Outstation artists should either arrange to take back their works in person or request the society to arrange the delivery of their works through courier and for this service they have to pay the charges to the courier. However if the outstation participants fail to collect or request the Society for the dispatch of the works within 30 days from the close of the exhibition. The society will have the right to dispose off the exhibit in any manner it deems fit. Artist will have no claim against the society.

PACKING & DISPATCH:

- a). Exhibits should be packed in strong cases to avoid damage.
- b). Exhibitors are advised to dispatch under Transit Insurance at their own expense.
- c). All packages containing exhibits for the exhibition dispatched by Road, Air or Post should be marked "THE CONTENTS ARE FOR THE 98TH ANNUAL ALL INDIA ART EXHIBITION 2025" and should be freight paid. Addressed to:-

The Chairman, All India Fine Arts & Crafts Society, 1, Rafi Marg, New Delhi-110001 d). Lids of boxes should be fastened with screws and not with nails. Each lid must bear on the under-side a card containing the name and address of the exhibitor and contents of the package for verification.

GENERAL:

- 1. All works for the All India Exhibitions of Art 2025 should be submitted duly framed keeping in view the stipulation of size and execution date. Any work exceeding size inspite of being selected will not be displayed.
- 2. All original exhibits must have a label pasted on the back side of the exhibit. The label is attached in prospectus.
- 3. Each exhibitor is required to send brief Bio-Data not more than 200 words and a passport size photo.
- 4. Artists, who have already got an award in the All India Exhibition of Art of AIFACS may be considered for award again only after three years in each category. However, the art works can be submitted by the artist in the category "NOT FOR COMPETITION".
- 5. Failure to comply with any of the rules laid down in prospectus may cause rejection of exhibits.

Submission of schedule will be deemed to imply acceptance of all the rules and regulations stated above.
